Broadridge Corporate Issuer Solutions, as transfer agent for Dominion Resources Inc., keeps shareholder records in compliance with your state's unclaimed property laws. If your account becomes inactive or if your address is no longer accurate, we are aggressive in alerting you as to the steps you must take to avoid the remittance of your property. Your account may be falling into a "dormant" account status either because your address is no longer valid; you have not cashed a dividend or sale check; or because of inactivity in your account. The property type that is eligible for remittance is listed above.

Should a response not be received **within 30 days from the date of this letter, the funds will be transferred to the state of (State Name) no later than (Transfer Date).** Upon transfer, this property will be in the custody of (State Name) to whom all future claims by the owner or legal heirs need to be directed. **Processing of the accounts for escheatment begins immediately after the requested response date, and once processing begins we are unable to stop or reverse this action.**

You may avoid escheatment of your property in one of three ways:

- 1) **Complete this form and return it to the address provided.**
- 2) **Contact us by phone by dialing 800-552-4034. You can keep your account current by accessing it through our automated telephone system. The automated system will ask you to enter your account number and the last 4 digits of your social security number or tax ID through your telephone key pad. Once you hear your account details, after you have successfully logged-in to your account, no further action is required; your account has been updated. You also have the option to request a replacement check, sell or transfer shares.**
- 3) **If you have access, log into your account at <http://shareholders.dom.com>.**

Please note that participation in the Dividend Reinvestment Plan is not considered investor generated contact. As an investor, continue to make periodic contact with Broadridge (i.e. call our call center to request a replacement check; sign in to your online profile and update your information; vote your proxy) to keep your date of last contact current and to avoid receipt of a similar letter in the future.

We are following the laws of your state of residence and want to help you avoid the escheatment of property deemed unclaimed. To avoid this transfer, we urge you to respond to this letter immediately.
