Thank you for contacting Broadridge Corporate Issuer Solutions regarding your Morgan Stanley Stock Account. In order to apply new W-8BEN information to your account, please complete the enclosed document. Please read the content carefully and follow all of the instructions provided. Things to remember before sending in your completed form:

- 1. Make sure the appropriate individual has signed the form. If you are signing for the shareholder, please include your title (i.e., POA, Custodian, Executor) after your signature and the proper documentation supporting your title if applicable (i.e. appointment documents).
- 2. Residents of a foreign country with which the United States has an income tax treaty may be eligible for a reduced rate of, or exemption from, the standard 30% withholding for foreign shareholders. In order to be eligible, you must have a certified W-8BEN on file.
- 3. If there is any change in your circumstances which would make any of the information on your W-8BEN no longer valid, you will need to recertify by submitting a new W-8BEN with the correct information.
